Motion: Approve the Credit by Exam proposal for An Sci/Dy Sci 101 to be effective in Summer of 2017; Gould; Albrecht

- Animal Science and Dairy Science's executive committees have approved this proposal
- Exam will be composed by the co-instructors of An Sci/Dy Sci 101 and available by February 2017 and will be reviewed annually
- Exam information will posted to a website and communicated to incoming freshmen and transfer students
- Exam will be available for matriculated students in the summer with the first exam to be proctored in June 2017
- An Sci/Dy Sci 101 has a lab component which will be addressed in exam by diagrams and questions regarding animal anatomy
- Concern about impact on An Sci/Dy Sci 101 enrollment
  - o Anticipated impact is 3 to 4 students

- Concern about whether the student will need to pay the exam fee as well as enrollment in the course
  - Students will only need to pay the exam fee as approved by campus policy
- Concern about whether the department will lose revenue due to students not enrolling in these courses
  - Due to the small number of students anticipated to take the exam, this is not considered to be a concern for the department.

5. Revision to Curriculum Committee Bylaws – Jeri/Nikki

Motion: Approve proposed changes to CALS Curriculum Committee Bylaws for review by Academic Planning Council; Gould; Lenertz-Lindemer

- Changes to Bylaws Include
  - Reduction of faculty serving on committee from 7 to 5 due to the overall decrease of faculty on campus
  - Reduction of student membership from 3 to 2 due to difficulty in finding students to serve on committee
  - o Update the title of Dean/Dean Designee to Academic Affairs
  - o Quorum will be defined as a majority of faculty and staff voting members
- Concern from committee about why students are included in committee
  - Student participation can be a valuable experience for students participating but students must be appointed by a student body which does not meet until after the beginning of the fall semester
  - Attempts to identify students prior to the academic year have been made but changes in student's schedules have made this difficult
  - If students do not count against quorum, there is no reason not to include them
- Suggestion that bylaw language regarding student participation be updated to "Reduce from 3 to up to 2"
  - o With current changes to defining quorum this language should not be necessary
- Concern that committee members represent the disciplines in the college
  - Language regarding that the breadth of disciplines be represented already exists

- 6. Lumen Update Nikki
- Campus has purchased a suite of software called CourseLeaf that encompasses several different modules
- The catalog module is in implementation and the new catalog (to be called The Guide) is set to go live in Summer 2017

- Another module is course proposal software
  - o OCP is the current course proposal system that will be replaced by this new software
  - o Currently the course proposal system is being reviewed for what information is needed in order to review a course proposal
  - o Hope it will be implemented fall 2017
  - o In the future there will also be program change and program review capacity which does not currently have an online counterpart
  - o All of the modules will be accessed through "Lumen," a portlet in the MyUW portal
  - o More updates will be coming in the future
- Concern about whether the Canvas software will be connected to this new software
  - o Canvas is connected to the Student Information System
- The software is designed to integrate all the catalog and course information into a single source
