COURSE PROPOSALS

Course Change Proposals

FOOD SCI 603: Senior Seminar

Request: change prerequisite from FS 602 & Sr. st in

FS or consent instructor to FS 602

The motion passed with conditional approval.

MS PhD Program in Epidemiology – The documentation for this PhD program will go to the board of regents twice. The first time will be for the planning phase.
